BUILDING INSPECTOR CLASS REQUEST:

MOTION by Mr. Stiles seconded by Mrs. Russo to approve the building Inspector's request to attend a seminar for: Sprinklers 1 & 2 Family Homes, Energy Code of NYS and Legal Aspects of Code Administration from May 3 through May 5 in Pomona, New York for \$300.00. Chief Rickard reported that he brought the monthly report earlier, he need a resolution to sign the STOP DWI contract and he discussed the STOP DWI budget modification.

HIGHWAY DEPARTMENT:

Mr. Hassenmayer reported that the finishing touches were being done at the park pavilion; need to finish the concrete pad and sidewalk there. He requested permission for all the guys to attend a safety seminar class tomorrow from 7:30 to 2:30, a paving seminar on April 1 in Marlboro from 8:30-1:00 for all guys, a Workzone traffic control class in Dutchess County – send 2 newest men for \$40.00/person on April 21st.

OLD SCHOOL:
