RESOLUTION TO ACCEPT THE PRIOR MEETING MINUTES:

COMMITTEE REPORTS:

POLICE DEPT. by Deputy Chief Byrne:

Councilman Fairweather added that Otisville Presbyterian Church is having their community day and they will also be planting flower bulbs for the community. H'way Supt. Hassenmayer stated that some will be planted out by the plow out front as well as the park.

BERGER FIELD ANNEXATION:

Supervisor Novak stated that although it was discussed at a prior meeting about the Berger Field annexation request from the Village Board, no formal action was taken.

RESOLUTION TO APPROVE ANNEXATION OF BERGER FIELD FROM THE VILLAGE INTO THE TOWN:

MOTION by Councilman Fairweather seconded by Councilwoman Russo to annex the portion of Berger Field that lies within the Village of Otisville in to the Town of Mount Hope. All in favor – Bell, Stiles, Novak, Russo, Fairweather. Carried.

HIDDEN VALLEY REPLACEMENT OF GRAVITY SEWER MAIN BID RESULTS:

Supervisor Novak stated that the bid results for the HV replacement of gravity sewer main on Oct. 19th were as follows: 5 bids were received. A letter of recommendation from Jim DeWinter was received on 10-21. His recommendation is Stoneykill Contracting for \$27,700.00.

RESOLUTION TO ACCEPT BID FROM STONEYKILL CONTRACTING FOR THE HV REPLACEMENT OF GRAVITY SEWER MAIN:

MOTION by Councilman Fairweather seconded by Councilman Bell to accept the bid from Stoneykill Cont. for the replacement of gravity sewer main in the amount of \$27,000.00. All in favor – Bell, Stiles, Novak, Russo, Fairweather. Carried.

DOT CALM DRIVE:

Supervisor Novak stated that in regards to the Garry Boyce subdivision (Dot Calm Drive), we need to accept the road dedication subject to receiving the title insurance. H'way Supt. Hassenmayer stated that he checked everything last week and there are still a lot of things that are incomplete. The aprons are not done. Every driveway out there has a swall in it and that will be a problem in the long run. His recommendation is that the aprons are completed first. Councilman Fairweather would like to see what is on Dean's list and would like to table this until next time.

RESOLUTION FOR POLICE COMPUTER USAGE POLICY CHANGE:

MOTION by Councilman Stiles seconded by Councilwoman Russo to amend General Order 10-095 Department Computer Usage by adding a new section:

15. Utilizing the New York State Division of Criminal Justice Services portal is for official department business only. Information obtained via the portal, including FBI CHS data or CHRI, shall not be shared with friends, relatives or used for the personal benefit of any department member. All FBI CHS data/CHRI is sensitive and shall be treated as such. Improper dissemination, in addition to being a violation of this policy, may constitute a criminal offense.
