The <u>workshop meeting</u> of the Town Board of the Town of Mount Hope was held at Town Hall on <u>September 24, 2012</u> at 7:30pm with the following present: Supervisor William Novak, Councilman Mike Bell, Councilman Gary Ketcham, Councilwoman Janet Sutherland and Town Clerk Kathleen Myers.

Following the Pledge of Allegiance, Supervisor Novak called the meeting to order at 7:30PM.

AT THIS TIME, Supervisor Novak called for a moment of silence in memory of past sewer plant employee Karlton Franck.

#### **RESOLUTION TO ACCEPT PRIOR MEETING MINUTES:**

MOTION by Councilman Bell seconded by Councilwoman Sutherland that the minutes of the Sept. 10, 2012 meeting as submitted by the Town Clerk are approved. All in favor — Bell, Ketcham, Novak, Sutherland. Carried.

#### **COMMITTEE REPORTS:**

#### **HIGHWAY DEPARTMENT by Highway Supt. Hassenmayer:**

H'way Supt. Hassenmayer stated that he needed to speak to Chief Rickard but will catch up with him tomorrow.

#### **VILLAGE OF OTISVILLE by Trustee Melton:**

Trustee Melton reported that the Village board voted to retain Mr. Simeone for fire district formation. He reminded everyone of the BLUE MASS. The steering committee will meet this Thursday. The veteran's are still selling bricks for the Village Park. Anyone interested should see a veteran for information. Supervisor Novak stated that the Town Board received copies of the Letter to Ed Myslinski from the Mayor. Councilwoman Sutherland asked about items on the list (stated in the letter) being taken care of already. Trustee Melton stated that 3 are already done – basically.

#### **HIDDEN VALLEY by Supervisor Novak::**

Supervisor Novak stated that there is nothing new to report.

#### **PLANNING BOARD by Chairman Gilmore:**

Chairman Gilmore advised the meeting was last week. The 4H plan is preliminary and consensus of the board is that it is okay for them to proceed. The Dragon Springs public hearing will be in November.

#### **RESOLUTION TO PROCEED FORWARD WITH JOINT FIRE DISTRICT FORMATION:**

MOTION by Councilman Bell seconded by Councilman Ketcham to proceed forward with a public information meeting and public hearing for the formation of a joint fire district between the Town of Mount Hope and the Village of Otisville. All in favor — Bell, Ketcham, Novak, Sutherland. Carried.

JOINT FIRE DISTRICT (continued):

\*\*\*Per Attorney Zack Kelson, the Town board needs to determine if there would be a conflict with Frank Simeone representing the fire district since he has represented the Town of Mount Hope in the past. Consensus of the board was that there was no conflict. Mr. Kelson will contact Mr. Simeone that both boards are ready to proceed. A 'RUMP' board needs to be established. Supervisor Novak has 3 possibilities: Mr. Zawasky, Joe Myers Sr., and Wayne Howell.

#### **TOWING FEES:**

Supervisor Novak stated that Chief Rickard spoke to him about the possibility of charging the tow companies a fee to come into the town to tow. Mr. Kelson stated that a local law would need to be established first. He will speak to Chief Rickard on this matter.

AT THIS TIME, Supervisor Novak asked Bryan Franck about the wake/funeral services for his dad, Karlton Franck. The services will be on Thursday 11-1 and they will go to fire house afterwards.

#### **RESOLUTION FOR HALLOWEEN CURFEW:**

MOTION by Councilman Bell seconded by Councilman Ketcham that anyone under the age of 18 must be off town roads after 9:00pm from October 26, 2012 through November 1, 2012 unless they are accompanied by a parent or guardian 21 years of age or older or if they are coming to or from a work assignment or school activity. All in favor – Bell, Ketcham, Novak, Sutherland. Carried.

#### **RESOLUTION TO APPROVE SUPERVISOR'S REPORT:**

MOTION by Councilman Bell seconded by Councilwoman Sutherland to approve the Supervisor's report for August 2012 as presented. All in favor – Bell, Ketcham, Novak, Sutherland. Carried.

#### **ENVIRONMENTAL FACILITIES CORPORATION:**

Supervisor Novak stated that he received a letter from EFC regarding \$7473.84 balance left on loan. They need to know whether or not we want to apply the remaining proceeds to the debt service principal. Board discussed this matter.

### RESOLUTION TO AUTHORIZE TRANSFER OF REMAINING FUNDS FROM ENVIRONMENTAL FACILITIES CORPORATION:

MOTION by Councilman Bell seconded by Councilman Ketcham to authorize the transfer of \$7473.84 to go towards the debt principal of the loan with the Environmental Facilities Corporation for our financing and to authorize the Town Supervisor to sign off on this. All in favor – Bell, Ketcham, Novak, Sutherland, Carried.

### RESOLUTION TO AUTHORIZE MOUNT HOPE COURT TO PROCEED WITH GRANT UNDER

MOTION by Councilman Bell seconded by Councilwoman Sutherland to authorize the Mount Hope Court to submit a grant application to the Office of Court Administration under JCAP. All in favor – Bell, Ketcham, Novak, Sutherland. Carried.

#### **2013 TENTATIVE BUDGET**

AT THIS TIME, Supervisor Novak stated that the 2013 Tentative Budget is complete. Town Clerk Kathleen Myers distributed the 2013 Tentative Budget packets to the board members.

#### RESOLUTION TO CHANGE THE FIRST MEETING IN OCTOBER:

MOTION by Councilman Bell seconded by Councilman Ketcham to change the first meeting in October to October 10, 2012 from October 8, 2012 at 7:30 due to the Columbus Day holiday and the way the budget calendar falls. All in favor — Bell, Ketcham, Novak, Sutherland, Carried.
