  - a) A profile from the crown of the road to a point thirty (30) inches inside of the property line.
  - b) The location of any tiles or drainage system, water mains or other public utility conduits.
- 4. The Town requires an application fee in the amount of \$50.00 made payable to the Town of Mount Hope.
- 5. The Town requires a check in the amount to be determined by the Highway Superintendent payable to the Town of Mount Hope representing a security deposit to ensure that the work is satisfactorily completed and the roadway restored to its original condition, as determined by the Town of Mount Hope Highway Superintendent. An extension could be granted if seasonal weather conditions prohibit paving. Security deposit will be held until completion.
- 6. The Town requires a Certificate of Insurance be on file, with the Town named as additional insurer, in the amount of \$1,000,000 before permit will be issued.

A minimum paved area of twenty (20) feet in length (by driveway width) with a 2% negative pitch, abutting town road must be established. Pavement base to consist of minimum 2" R.O.B. gravel, Item #4 or crusher run. Pavement to be 2 ½" asphalt with 3/8" stone mix (approved NYS 6F top mix #403.17). Additional drainage swales, culverts etc. will be determined on a case by case basis.
No driveway shall be permitted within fifty (50) feet of any public highway intersection.
No driveway will be permitted where a sight distance is less than one hundred (100) feet in each direction.
No driveway entrance shall be closer than ten (10) feet to side property line and side lot lines to be flagged.
Driveway markers (where driveway will be cut in off town highway) must be in place at exact location and correct width for Highway Superintendent inspection before permit will be issued. Markers must be of wooden stake or metal pipe type painted red or red flagged.
A fully dimensioned plan of the proposed driveway shall be attached to each application for a permit required hereunder.
Any culvert pipe required to be installed at such driveway entrance or exit shall be of A.D. S. N-12 type, no smaller than 15 inches in diameter and no shorter than 30 feet in length.
A runoff area of stone or shale the width of driveway and a minimum of one hundred fifty feet (150) long is required to prevent driveway mud from being tracked onto town roadway. If mud is tracked onto town roadway the permit holder will be responsible for its removal.
